AGM 2022 Proposed Branch Rules changes

6. Branch Structure / AGM Add to point 1 after 1st paragraph

Existing First paragraph

There will be up to four Annual General Meetings, to be held in appropriate areas of the County, as determined by the Branch Committee. Members can attend only one AGM, unless standing for election or proposing / seconding a motion / amendment. The Branch Committee will consider the reimbursement of facilitation and transport costs, to encourage attendance.

Where more than one AGM is held, the votes at each meeting shall be aggregated to formulate Branch policy and determine the outcome of elections.

The Branch AGM will be held either as a physical meeting, a virtual meeting or as a hybrid of both depending on local circumstances. The format for the AGM will be reviewed annually and decided upon by the January Branch Committee.

Unless otherwise stipulated by National Rules, all Branch meetings can be either physical, virtual or a combination of both (hybrid) as agreed by the Branch Committee or the appropriate officers.

Branch Committee quorum

Amend quorum from 15 voting members to 12 voting members.

Existing wording

The quorum for the Branch Committee shall be 15 voting members of the Committee to enable Branch business to be efficiently conducted. Every possible effort shall be made to maximise attendance. (The quorum will be reviewed annually)
